Smarty Streets Roll-Out

- 8 IIS have signed Partner Agreements.
 - These IIS are: Alaska, Washington State, Alabama, Puerto Rico, California, Indiana, Louisiana, and Rhode Island.
- An Inaugural JDI User Group update was given.
 - This user group is comprised of anyone from participant sites who works with SmartyStreets and wants to be on the call.
 - The purpose of the user group is to assist participant sites to reach full implementation and provide a platform for peer-to-peer communication and troubleshooting.
 - The user group will be facilitated by Josh Hall (MI) and Steve Murchie (Envision) and held approximately every 2 weeks.
 - o The user group will be evaluated after 3 months and 6 months.
 - The inaugural meeting will be held on August 29th.
- The next edition of *SnapShots* will feature a profile of Josh Hall and the address cleansing process he and his team created in Michigan.
- Moving forward, there will be continued communication to the community about SmartyStreets via multiple platforms.
- The goal is to have another 7 partners by October 1st and another 9 partners by the end of December.
- There is still a lot of interest in using SmartyStreets and uptake is to be expected.

Discussion: Refined Project SummariesBill Brand, PHII, Cochair

- The DQA Tool project summary can be found here.
 - This is an open source tool initially developed by Nathan Bunker to manage the data quality of HL7 interoperability.
 - o The tool can look at both real-time or batch incoming messages to quickly measure the data quality regardless of the platform an IIS is using.
 - In addition to implementation, a large part of this project concerns the governance, maintenance and evaluation of the tool.
 - A subgroup will be created if this project is selected.
 - There is concern that IIS implementers need to have a say in the project selection since it is affecting them directly.

- This project is an evaluation of a variety of third-party tools.
 - The goal of this project is to evaluate what each tool does and how it can be of use to IIS.
 - Leveraging existing tools may benefit this project.
 - A subgroup will be created if this project is selected.
- This project has gone from medium to high urgency.
- This project could be a part of a much larger strategy for other projects to adopt. For
 instance, the WIR community is interested in looking at duplication that occurs in the
 WIR application.
- There is concern that deduplication may not require a single tool but multiple strategies. Wording may need to be revised in the project summary to accurately reflect this.
- Comments about the voting process:
 - o Voting for the advisory group will be available until Friday, August 11th.
 - There is a concern that the JDI group might not best represent the community and as such should not select the next project.
 - o As non-IIS, should vendors vote?
 - o It was suggested that voting be expanded to include the AIRA Board.
 - There is concern that involving more people on the project selection process will delay the project.
 - Weighting votes can be a method revisited at a later time.
 - Action Item: Bill Brand and Maureen Neary will discuss with Mary Beth Kurilo whether a broader vote is needed for the selection of the next JDI project.
