As the US population continues to become more mobile, there is a greater need to query and exchange information across jurisdictional lines. Many regional exchanges are already underway, either between neighboring jurisdictions (OR-WA) or between city-and-state jurisdictions (NYS-NYC). In addition, discussions are underway exploring the possibility of adding an IIS Functional Standard focused on interjurisdictional exchange. Given these and other efforts, there is a growing need to provide a comprehensive and centralized view of IIS-IIS data exchange activities across the US, as well as a need to develop a more comprehensive policy, technical and programmatic strategy.
