- Geocoding is being done using manual processes for clients and providers.
- Geocoding has been in the Oregon system since March 2015, although it has not been used yet due to resource concern.
  - SmartyStreets will help with the manual processes.
  - SmartyStreets approval is still in process.
- Changes in geocoding are tracked in staging tables and the system makes the changes to avoid manual errors.
  - A weekly process looks at the tables and updates the IIS address information.
  - These changes are also tracked in audit tables with a new audit source ID as a precaution.
  - This was allowable within the FLA.
- Set-up was easy. Table configurations needed to be set up.
- Documentation on the FDD and the manual processes are available if useful.
- Approval for SmartyStreets is in the Oregon approval process.
- The SmartyStreets list will replace two types software that Oregon currently uses.
- Minnesota is interested in looking at Oregon's staging tables functionality.
- AIRA is creating an SmartyStreets User Group that will begin on Tuesday, August 29<sup>th</sup>, at 1pm ET.
  - The user group will be facilitated by Josh Hull and Steve Murchie.
  - This resource will be available for three to six months for a peer-to-peer platform and can be joined at any time.

- A presentation given by Minnesota IIS staff on the Documentation Project can be found [here](#).
  - The goal of MIIC is to maintain a robust repository of high quality data to reduce the burden of vaccine preventable diseases.
  - The goal of MIIC system documentation is to gain and document a thorough understanding of the system in order to better maintain and support it.
  - MIIC pursued a company to conduct an external review.
  - Sogeti reviewed existing documentation, hardware, comprehensive code and hoped to compare Minnesota's system to other jurisdictions.
  - Sogeti created four documents for MIIC:
    - A physical architecture document contained the locations and version of software and the different resources allocated to them.
    - The logical architecture document contained data flow diagrams for data exchange and the forecaster, RunMatch, web-services, client history in the user interface, and how the DataMart is populated.

- The code deficiencies document contained security and coding best practices that needed to be followed.
- A final report document included how to improve documentation moving forward.
- MIIIC still needed to find out how components are processing their data.
- As a result, Minnesota created:
  - A functional requirements document for their IIS to describe the information provided, how it gets in, and how users interact with IIS
  - A business rules document to list the detailed rules for each of the system's functions
    - This document will need to be updated periodically to stay up-to-date.
  - A data dictionary document to describe data structures and relationships, allowable values and ISA standards
  - A design specifications document to index how application codes will meet each of the requirements and implement each of the rules.
- There is a lot of work that is yet to be done, but Minnesota is already seeing benefits from their work including being able to solve data exchange problems.
  - The hope is a new developer will be able to be brought up to speed on the system quickly because of this project and its changes.
- Minnesota is willing to make their shareable documents available on the AIRA Repository as examples for other IIS.
- The functional requirements, business rules, and documents from Sogeti should be transferrable to the other WIR platforms projects.
